PPT Presentation and Submission of Internship Diary & Certificate

This is to inform to all the students who are going through an internship during winter vacations in academic session 2025-26.

You are required to follow the below rules relating to Submission of Internship Diary & Certificate and PPT Presentation thereof.

1. You are required to prepare a PPT relating to your respective internship mentioning your observation, understanding and experience throughout the internship during winter vacation in academic session 2025-26 and present the same at the Institute on 24.02.2026, 25.02.2026 & 26.02.2026
2. The aforesaid PPT must not be of more than 5 slides including cover page.
3. The cover page must contain the name, roll no., year/semester of the student the chamber/law firm/ advocate/institution where the internship was carried out and the duration of internship with dates.
4. The PPT must be submitted in one day advance in soft copy to the designated faculty.
5. The duration of PPT presentation shall be of 2 minutes.
6. A photocopy of the Internship Diary and Internship Certificate shall be submitted to the designated faculty only after the completion of PPT presentation on the date of presentation.
